

J&J 90TH ANNIVERSARY SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The J&J 90th Anniversary Sweepstakes ("Sweepstakes") is sponsored by J&J Ventures Gaming, LLC, Terminal Operator, 1400 South Raney Street, Effingham, Illinois 62401; Curo Group, LLC, Licensed Supplier, 9651 Clayton Road, Suite 2A, St. Louis, MO 63124; and participating Licensed Establishments (each and collectively, "Sponsor").

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on August 28, 2019 at 12:00 AM Central Time ("CT") and ends on October 31, 2019 at 11:59:59 PM CT ("Sweepstakes Period"). The Sweepstakes will consist of the following nine (9) separate entry periods (each an "Entry Period"):

Non-winning entries will **not** carry forward into subsequent Entry Periods, however all non-winning entries will be entered into a "Grand Prize Drawing", to be conducted at the end of the Sweepstakes Period. The Sponsor's computer is the Sweepstakes official clock.

- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of Illinois, Wisconsin, Indiana, Kentucky, and Missouri who are at least twenty-one (21) years old at the time of entry. Employees of Sponsor, third party administrator ("Administrator"), and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail

address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical addresses or e-mail addresses.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant may visit any of the participating Licensed Establishments that operate Sponsor's video gaming machines ("Participating Establishments") within a specific region ("Region", as outlined in the Appendix of these Official Rules) during the Participating Establishment's regular posted business hours. Then, the eligible entrant must complete and submit the requested information on the Sweepstakes tablet ("Sweepstakes Tablet"), which may include, but is not limited to, complete first and last name (no initials), valid e-mail address, street address (no P.O. Boxes), city, state, ZIP Code, date of birth, and daytime telephone number. Upon completion of the requested information, the entrant will receive one (1) entry into the applicable Entry Period and one (1) entry into the Grand Prize Drawing.

Entry Limits: There is no purchase or fee required to enter this Sweepstakes. A purchase will not improve the chances of winning. Limit one (1) entry per Participating Establishment per person per day. A day is defined as starting at 12:00 AM CT and ending at 11:59:59 PM CT on a calendar day. If entries are received from the same person, e-mail, or phone number in excess of the stated limits, that entrant's entries may be considered invalid, at Sponsor's sole discretion.

Entries made by any other individuals or any entry originating at any other event or method, including but not limited to commercial sweepstakes subscription notification and/or entering service websites, will be declared invalid and disqualified for this Sweepstakes. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor and/or Administrator's satisfaction, the affected entry will be deemed ineligible in the sole discretion of the Sponsor and/or Administrator. Only entries submitted in accordance with these Official Rules will be accepted.

4. **RANDOM DRAWINGS:** On or about each of the Drawing Dates listed in Section 1, the Administrator will randomly select one (1) potential "Weekly Winner" from all eligible entries received for a Region in the applicable Entry Period. On or about November 1, 2019, the Administrator will randomly select one (1) potential "Grand Prize Winner" from among all eligible entries received from all Regions during the entire Sweepstakes Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. **PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**

A. Weekly Prizes (81 total; 1 per Entry Period per Region): Each Weekly Winner will receive a \$900 check ("Weekly Prize"). Eighty-one (81) total Weekly Prizes are available in the Sweepstakes (one [1] per Region per Entry Period). The ARV of each Weekly Prize is \$900.

B. Grand Prize (1): The Grand Prize Winner will receive a \$90,000 check ("Grand Prize"). Only one (1) Grand Prize is available in the Sweepstakes. The ARV of the Grand Prize is \$90,000.

C. ARV: The total ARV of all prizes available in the Sweepstakes is \$162,900.

D. Odds of Winning: The odds of winning a Weekly Prize depend on the total number of eligible entries received in a Region for each Entry Period. The odds of winning the Grand Prize depend on the total number of eligible entries received in all Regions during the entire Sweepstakes Period.

6. **HOW TO CLAIM A PRIZE:** Receiving a prize is subject to verification of eligibility and compliance with these Official Rules. Each potential winner will be notified via e-mail, or phone by Sponsor or its authorized designee at the e-mail address or phone number provided at the time of entry. Before being declared a winner, a potential winner will be required to execute an Affidavit of Eligibility/Liability & Publicity Release and tax acknowledgment (“Affidavit”) sent with the e-mail notification. A potential winner must return a fully executed and notarized Affidavit to the Sponsor or its authorized designee within two (2) calendar days from the date it is received as being sent to each potential winner. Each potential winner will be required to sign a publicity release to accept a prize. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, does not complete the required paperwork, or declines to accept a prize, the prize may be forfeited. If a Weekly Prize is forfeited, the Weekly Prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries received from the applicable Region in the applicable Entry Period, as determined by Sponsor in its sole discretion. If the Grand Prize is forfeited, the Grand Prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible entries received from all Regions during the entire Sweepstakes Period, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded.

Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no prize substitution, exchange, or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of the prize or force majeure, at Sponsor’s sole and absolute discretion. Sweepstakes Entities shall not be held responsible for any delays in awarding a Prize for any reason. Sponsor will issue an IRS Form 1099-MISC to each winner.

7. **LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents (“Released Parties”) are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Sweepstakes; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a prize; or (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or

If, for any reason, the Sweepstakes is not capable of running as planned, Sponsor reserves the right, at its sole and absolute discretion, to cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of winners in a manner it deems fair and reasonable, including the selection of a winner from among eligible entries received prior to such cancellation, termination, modification or suspension. In no event will more prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical, administrative, printing, production, computer or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO**

ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. Entrant may choose to "opt in" to receive future promotional opportunities for J&J Ventures Gaming during Sweepstakes registration.
10. **PUBLICITY RIGHTS:** By participating in this Sweepstakes, each entrant agrees to allow the Sponsor and Sponsor's designee the perpetual right to use his/her name, address (city and state), biographical information, likeness, picture and other information and content provided in connection with the Sweepstakes for promotion, trade, commercial, advertising, and publicity purposes in all media worldwide including, but not limited to, on television and the Internet, without notice, review or approval and without additional compensation, except where prohibited by law.
