



OFFICIAL GIVEAWAY RULES ("Official Rules")

1. **Sponsorship.** The (See section 1 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES) Giveaway (the "Sweepstakes") is sponsored by (See section 2 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES) with a principal place of business located at (See section 2 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES) (the "Participating Location") and J&J Ventures Gaming LLC, with a principal place of business located at 1500 S. Raney Street, Effingham, Illinois (together with the Participating Location, the "Sponsors").

2. **Sweepstakes Procedure.** Participants may enter the Sweepstakes through an On-Site Entry, as described below (an "Entry"). The Sweepstakes shall be open to all patrons (regardless of whether such patron has or intends to play a Video Gaming Terminal). Each person who enters the Sweepstakes via an Entry is referred to herein as a "Participant." In connection with an Entry, a Patron may be required to provide the Participant's: [(a) first and last name, (b) telephone number, (c) physical address and (d) e-mail address (the "Required Participant Information")]. The Required Participant Information must be accurate and current as of the date of the Entry. A Participant is permitted one (1) Entry per day. All Participants must enter themselves in the Sweepstakes; a third-party (including the Sponsor's employees) may not enter another in the Sweepstakes. In the event that a Participant fails to comply with any of the requirements contained in this Section or that are otherwise provided for herein, at the sole determination of the Sponsor, such Participant may be disqualified from the Sweepstakes. Moreover, at the sole determination of the Sponsor, all of that Participant's Entries may be deemed null and void, not honored or acknowledged and may be grounds for forfeiture of his/her prizes.

ON-SITE ENTRY: Participants may enter the Sweepstakes via (See section 6 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES) at the Participating Location during normal business hours. Participant is required to fill out the entry form in its entirety.

3. **NO PURCHASE NECESSARY.** NO PURCHASE IS NECESSARY TO ENTER OR WIN THE GIVEAWAY. FURTHER, A PURCHASE (INCLUDING, WITHOUT LIMITATION, ANY PRODUCT, GOOD OR SERVICE SOLD BY THE SPONSOR) WILL NOT IMPROVE A PARTICIPANT'S CHANCES OF WINNING WITH AN ENTRY.

4. **Drawing.** The drawing will take place at the Participating Location on (See section 4 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES) Central Time (the "Drawing Date"). Entries will only be accepted (See section 3 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES). Winner will be announced on (See section 7 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES) by (See section 7 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES). Winner can claim prize by (See section 8 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES) and claim period will expire by (See section 9 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES). If the winner does not claim the Prize within the Claim Period, the Prize shall be forfeited and a secondary drawing shall occur at a date and time decided upon by the Sponsors (the "Secondary Drawing"). No additional Entries shall be accepted between the expiration of the Claim Period and the Secondary Drawing.

5. **Prizes, Prize Values, Odds of Winning and Collecting Prizes.**

- (a) By entering the Giveaway, Participants are eligible to win a (See section 5 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES) valued at approximately \$(See section 5 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES).
- (b) The odds of winning depend entirely on the number of Entries made prior to the Drawing Date.

6. **Eligibility.** The Giveaway is open to all legal residents of the United States of America who are twenty-one (21) years or older at the time of entry. The Giveaway shall be open to all patrons who meet these criteria, regardless of whether such patron has or intends to play a Video Gaming Terminal. 7. **Use of Disclosed Information.** Information transmitted to the Sponsors will generally be treated as non-confidential and non-proprietary. Except where prohibited by law, entry constitutes permission to use each winner's name, biographical information and/or likeness for online posting and/or any other written or photographic advertising and publicity without additional compensation. Further, by entering the Giveaway, the Participant is granting Sponsor

permission to use his/her contact information to provide him/her with marketing or other informational materials related to Sponsor.

8. **Social Media Disclosure.** Although the Program or the Giveaway may be advertised on the Facebook pages, Twitter accounts, Instagram accounts, YouTube channel or other social media platforms of the Sponsor, neither the Program nor the Giveaway are in any way sponsored, endorsed or administered by, or associated with, Facebook, Twitter, Instagram, YouTube or other social media platforms. Participants are providing their information to the Sponsor and not to Facebook, Twitter, Instagram, YouTube or other social media platforms. The information Participant provides will only be used by the Sponsor and its agents. By entering, Participants provide a complete release of Facebook, Twitter, Instagram or YouTube from any and all responsibilities implied or provided by the Sponsors and that the Program and the Giveaway are in no way sponsored, endorsed or administered by, or associated with, Facebook, Twitter, Instagram or YouTube.

9. **Miscellaneous.**

- (a) By entering, Participants unconditionally agree to be bound by these rules and the decisions of the Sponsor, which shall be final. Sponsor reserves the right to disqualify any Participant or winner who, in its sole suspicion, tampers with the entry process, violates these rules, or acts in an unsportsmanlike or disruptive manner.
- (b) All federal, state, and local laws apply. Any winner of a prize with a retail value of \$600 or more will be required to provide tax information and will be sent an IRS Form 1099. Each winner is solely responsible for reporting and paying all applicable federal, state and local taxes related to the prize.
- (c) Sponsors and, as applicable, the employees, officers, directors, shareholders, agents, and representatives of the Sponsors, their affiliates, subsidiaries, and advertising, promotion and legal advisors are not responsible for and shall not be liable for: (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible Entries; (ii) any condition caused by events beyond the control of either Sponsor that may cause the Giveaway to be disrupted or discontinued; (iii) any injuries, losses, or damages of any kind caused by a prize or resulting from acceptance, possession, or use of the Prize, or from participation in the Giveaway; or (iv) any printing or typographical errors in any materials associated with the Giveaway.

- (e) If any provision(s) of these Official Rules is held to be invalid or unenforceable, all remaining provisions hereof will remain in full force and effect. Sponsors reserve the right in its sole discretion to supplement or make changes to these Official Rules without notice.
- (f) Participants agree that any dispute arising out of this Giveaway shall be resolved individually without class action and exclusively by the state and federal courts in (See section 2 on SWEEPSTAKES: SCHEDULE TO OFFICIAL GIVEAWAY RULES) County, Illinois under the laws of Illinois, without regard to that state's conflict of laws principles.
