

### **OFFICIAL GIVEAWAY RULES ("Official Rules")**

# NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE A PARTICIPANT'S CHANCES OF WINNING.

1. **Sponsorship**. The *Prize Party*, this "<u>Giveaway</u>", is sponsored by J&J Ventures Gaming, LLC ("J&J"), with its principal place of business located at 1500 S. Raney Street, Effingham, Illinois ("J&J's Main Office") and each of the participating Player PAYBACK® locations set forth on the list of Prize Party Participating Locations, which shall be posted by June 26, 2023, at: <u>https://www.jjventures.com/news/</u> (each, a "<u>Participating Location</u>", collectively the "<u>Participating Locations</u>", and together with J&J, the "<u>Sponsors</u>").

2. Program Procedure and Enrollment. Participants may enter this Giveaway through an On-Site Entry via the Player PAYBACK® App, as described below (an "Entry"). Participants may be required to present valid, government-issued photo identification for proof of age at the time of entry at a Participating Location. This Giveaway shall be open to all patrons (regardless of whether such patron has or intends to play a Video Gaming Terminal or otherwise make a purchase) that are enrolled in the Player PAYBACK® rewards program (the "Program") and has a valid phone number. Each person who enrolls in this Giveaway is referred to herein as a "Participant." Sponsors reserve the right to deny anyone from participating in this Giveaway at any time in Sponsors' sole discretion, and without recourse. In connection with initial enrollment in the Program, a Participant will be required to provide the following information: (a) first and last name, (b) telephone number, (c) gender, and (d) date of birth (the "Required Participant Information"). In connection with a subsequent Entry, a Participant will be required to provide a telephone number. The Required Participant Information must be accurate and current as of the date of initial enrollment and as of each subsequent Entry. A Participant is permitted one (1) Entry per day per Participating Location and applying the Prize Party Entry(ies) (as defined below) toward one (1) Participating Location per day, where applicable. Each Participant is limited to creating one (1) account for the Program, which can be used for all Participating Locations.

ENTRY: Participants may enter this Giveaway by visiting a Participating Location and logging into the Player PAYBACK® App that is available on the J&J designated kiosk located near the gaming area by entering their phone number during such Participating Location's normal business hours ("<u>Check-In</u>"). Entries will only be accepted from 12:00 AM (CST) on July 11, 2023 through 11:59 PM (CST) on August 20, 2023 (the "<u>Entry Period</u>").

a. **PRIZE PARTY:** A Participant will be automatically entered into this Giveaway upon completion of a valid Check-In. A Participant is limited to one (1) Entry per day, per Participating Location. In addition to the one (1) Entry per day, per Participating Location, upon a valid Check-In, depending on Participant's Program reward level status as of the last day of Q2 2023, Participant will receive an additional Entry for that Check-In. The Program Insider Level will receive one (1) additional entry, the Elite Level will receive two (2) additional entries, and the VIP Level will receive three (3) additional entries (the "Prize Party Entry(ies)"). The Prize Party\_Entry(ies) can be applied toward one (1) Participating Location of the Participant's choosing per day.



It is the responsibility of the Participant to ensure that the Required Participant Information is accurate at the time of each Entry. All Participants must enter themselves in this Giveaway; a third-party (including an employee of any of Sponsors) may not enter this Giveaway. In the event that a Participant fails to comply with these Official Rules, at the sole determination of J&J, such Participant may be disqualified from this Giveaway. Moreover, if a Participant fails to comply with these Official Rules, at the sole determination of J&J, all that Participant's Entries may be deemed null and void, not honored or acknowledged, and may be grounds for forfeiture of Participant's prize(s). 3. **NO PURCHASE NECESSARY.** NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS GIVEAWAY. FURTHER, A PURCHASE (INCLUDING, WITHOUT LIMITATION, ANY PRODUCT, GOOD OR SERVICE SOLD BY THE SPONSORS OR A PARTICIPATING LOCATION) WILL NOT IMPROVE A PARTICIPANT'S CHANCES OF WINNING WITH AN ENTRY.

## 4. Drawing.

- a. PRIZE PARTY. The drawing will be conducted by a representative of J&J and will take place at J&J's Main Office on August 21, 2023 (the "<u>Prize Party Drawing Date</u>"). An employee of J&J will notify the Participating Locations of the winner via email by August 22, 2023. The Participating Location shall contact the winner via telephone within 24 hours of receiving the winner notification email from the J&J employee (the "<u>Prize Party Notice</u>") and the winner shall have five (5) days from the date and time of the Prize Party Notice to claim his or her prize (the "<u>Prize Party Claim Period</u>"). If the winner does not claim the Prize within the Prize Party Claim Period, the Prize shall be forfeited, and a secondary drawing may occur at a date and time decided upon by the Sponsors (the "<u>Prize Party Secondary Drawing</u>"). No additional Entries shall be accepted between the expiration of the Prize Party Claim Period and the Prize Party Secondary Drawing.
- **b. Grand Prize Drawing.** The drawing will be conducted by a representative of J&J and will take place at J&J's Main Office on August 21, 2023 (the "<u>Grand Prize Drawing Date</u>"). An employee of J&J shall contact the winner via telephone within 48 hours of the Grand Prize Drawing Date. Prior to J&J mailing each Grand Prize (as defined below) winner a check made payable to such winner, the winner must provide J&J with the information required to complete Form 1099-MISC and must mail J&J a completed W9 within ten (10) days of the Grand Prize Drawing Date. If the winner does not promptly provide the required information sufficient to complete Form 1099-MISC and/or fails to return a completed W9, the winner shall be deemed to have forfeited the prize, and a secondary drawing may occur at a date and time decided upon by the Sponsors.

## 5. **Prizes, Prize Values, Odds of Winning and Collecting Prizes**.

- i. **PRIZE PARTY**. One (1) Participant from each Participating Location will win the cash prize of three hundred and fifty dollars (\$350.00) (the "<u>Runner-Up Prize</u>"). J&J shall mail the Runner-Up Prize to the winner in the form of a check made payable to the winner and sent via certified mail to the address obtained when the winner is notified by the Participating Location by phone.
- Grand Prize. At the end of the Giveaway, all Entries from all Participating Locations will be combined and ten (10) Participants from each of the Member, Insider, Elite, and VIP tiers will win a grand prize ("Grand Prize", and together with Runner-Up Prize, the "Prize"). The Grand Prize options for each tier are shown below. Prize values will increase for each tier and the Grand Prize values will be based on the number of Participating Locations.

J&J will mail each Grand Prize to the winner's address obtained when the winner is notified by phone. If the cash option is chosen, a check made payable to the winner will be sent via certified mail.

- iii. The Grand Prize winner chosen from each tier will still be qualified to win the Runner-Up Prize. A Participant is eligible to win more than one Runner-Up Prize.

6. Eligibility. This Giveaway is open to all legal residents of the United States of America who are twentyone (21) years or older at the time of entry and are enrolled in the Program. This Giveaway shall be open to all patrons who meet these criteria, regardless of whether such patron has or intends to play a Video Gaming Terminal. Employees of the Participating Locations and the immediate family members of each employee are not eligible to Check-In, or otherwise participate in this Giveaway at the location where that employee is employed. An "immediate family member" is defined to mean spouse, parent, grandparent, child or sibling. In-laws are not considered to be immediate family members. As applicable, employees of J&J, its affiliates, licensees, franchisees, advertising and promotional agencies are not eligible to participate in this Giveaway.

7. Use of Disclosed Information. Information transmitted to the Sponsors will generally be treated as nonconfidential and non-proprietary. Participant may opt out of receiving such materials or messages by following the opt-out instructions set forth in the Player PAYBACK® App or the applicable text message or e-mail. If Participant opts out, Participant authorizes Sponsors to send an email and/or text message confirming the request to opt out and Participant will no longer be enrolled in the Program or eligible to participate in this Giveaway. Participant acknowledges that additional charges from their mobile phone carrier may apply for text messages and Participant consents to same.

- (b) All federal, state, and local laws apply. These Official Rules will be governed by the laws of the State of Illinois. If any provision of these Official Rules is deemed invalid or unenforceable, such provision shall be deemed void only for the specific jurisdiction at issue, but all other provisions will remain in full force and effect.
- (c) For each of the Grand Prizes, the Internal Revenue Service (IRS) requires Form 1099-MISC for U.S. residents for each winner who receives a prize if the amount of the prize is \$600 or more. The winner must provide J&J with the required information in order for J&J to complete Form 1099-MISC.
